Terms of This Installment Payment Agreement — Current Term Only

- OPEN ONLY TO STUDENTS WHO ARE** —Not in arrears (past due) for any University charge or loan.
 —Without a previously unsatisfactory University credit record.
 —Matriculated New York University Students.
- INITIAL PAYMENT** —50% of the net amount due for the *Summer Term Only*. An amount due for prior terms must be paid in full.
- SUBSEQUENT PAYMENT** —The 50% deferred balance plus interest is due in June 6, 2008
- PENALTY FEE** — A \$25 penalty fee will be charged on any late payments.
- PREPAYMENT** —There is no prepayment penalty.
- APPLICATION FORM** —A separate application and agreement is required for each term this plan is used.
