

## **Learn and Serve Course Development Grants**

### **Faculty Partnerships with University Settlement's Tutoring Programs**

#### **Purpose of Grant:**

NY/PA Campus Compact has awarded New York University a three-year grant from the Corporation for National and Community Service Learn and Serve America Program to strengthen and expand service learning throughout the NYU campus. Funding covers financial support and the provision of technical assistance to select faculty as they incorporate service-learning into new and existing courses. Grant recipients agree to place their students at **University Settlement House** to provide tutoring for K-12 youth and adult learners from disadvantaged backgrounds throughout the semester.

#### **Background on University Settlement House:**

As the first settlement house in the United States, founded in 1886, University Settlement embodies the settlement ideal – working from within the community to buoy the lives of individuals, families and the collective whole. The Settlement serves as a haven for Lower East Siders of all ages, from infants to the elderly, offering child care, pre-school, housing assistance, mental health services, college and career preparation, crisis intervention, a senior center, arts events, English classes, after-school programs, summer camps and more.

#### **Financial Support:**

Grant recipients receive \$2,000 for professional development or budget relief as determined by individual schools and agree to: (1) Participate in three, two hour long faculty development workshops. Dates to be determined in consultation with grant recipients. (2) Integrate Service Learning into a new or existing course within one calendar year following the workshops. (3) Place Learn and Serve students at University Settlement to provide weekly tutoring to K-12 youth or adult learners.

#### **Technical Assistance:**

The workshop series provides training in matters of Service Learning course design, classroom based reflection activities, and evaluation and assessment.

#### **Application Deadlines:**

Applications are due on Tuesday, July 1, 2008. Workshop sessions will be held during late summer and early fall.

- What experience, if any, do you have with academic and community engagement, volunteering/community service, or active learning?

**Application Deadline: Tuesday, July 1, 2008**

Please keep in mind that all grant recipients agree to:

Participate in all three faculty development workshops. Each workshop runs 2 hours long. Date to be determined in consultation with grant recipients.

Integrate Service Learning into a new or existing course within one calendar year following the workshops.

Place students at University Settlement to provide weekly tutoring in educational programs.

**Definition of Service Learning:**

Service Learning is an instructional approach that draws explicit connections between classroom learning and immediate issues in the community by creating opportunities for students to be active in community-based service or research as part of the course.
