Fall 2008 - Housing Reservation Payment Notice – *Extended Deadline* - June 6, 2008

This form is for students who are eligible for 2008 housing as determined by the Undergraduate Admissions Office or their respective Graduate Admissions Office. Eligible students will be contacted via their permanent home address and/or their NYUHome email account with specific housing application instructions. Students must submit the on line housing application **and** the housing reservation payment by **June 6, 2008**.

The reservation payment will be applied to your **fall term 2008** housing charges. **DO NOT WAIT UNTIL THE LAST MINUTE.** *If payment AND application are not received by **June 6**, your fall 2008 housing reservation will be **canceled**.*

2008 Important Dates – Revised June 3, 2008

June 6, 2008 (*Extended Deadline*)

Housing online application and reservation payment due
New Students (freshmen, transfers and graduates) pay \$1000.

In early July the Office of the Bursar will send you a statement reflecting your fall tuition charges and **estimated** housing charges. Your account will be adjusted (in late July) once your housing assignment has been made. Your assignment notice will reflect your actual housing charge. *Actual charges may be higher than the estimate you initially receive depending upon your actual assignment.*

June 15, 2008

Notification of housing status for new graduate students
New graduate students will be pre-notified whether their housing placement has been secured.

July 18, 2008

Housing cancellation deadline

All cancellations must be submitted in writing.

The housing license is a financial commitment for both fall 2008 and spring 2009. The official license period is August 24, 2008 to May 16, 2009.

Cancellation after the **July 18, 2008** deadline is not permitted except for documented extenuating circumstances that have been approved by a review committee. The reservation fee may not be refunded for cancellations authorized after **July 18, 2008**.
