SALARY DEFERRAL AGREEMENT FOR 2009

New York University (“NYU”) and the above named employee (the “Employee”) hereby agree as follows:

1. The Employee elects to defer \$_____ of salary for the remainder of 2009. Deferrals for 2009 may not exceed \$16,500 and will be made in equal amounts per pay period beginning on the later of April 1, 2009 or the first pay period that commences after the end of the month in which this Agreement is received, accepted, and executed by the NYU Benefits Office. This Salary Deferral Agreement (the “Agreement”) applies only to salary amounts payable after the Agreement becomes effective.
2. The University shall invest the amount deferred in accordance with the directions contained in the most recent Investment Selection Form submitted by the Employee and accepted by the University.
3. This Agreement is legally binding and irrevocable with respect to amounts payable while it is in effect, except that the University may reduce the amount deferred if it determines that such amount exceeds the applicable limitations of Internal Revenue Code Section 457.
4. This Agreement shall supersede any prior Salary Deferral Agreement and shall continue in effect until terminated or superseded or the Employee ceases to be eligible to participate in the Plan. Either the Employee or the Employer may terminate this Agreement with respect to amounts not yet earned by the Employee by informing the other party in writing.
5. This Agreement provides only for deferrals during 2009. To defer salary in 2010, the Employee must enter into a new Salary Reduction Agreement.
