SECTION 2: INVESTMENT Allocation (You can divide the contribution between TIAA CREF and or/ Vanguard or have it all go to one investment company)

I hereby authorize the University to allocate the NYU contribution made to the NYU Retirement Plan for Adjunct Faculty Members as follows (check one):

This allocation will be sent to TIAA-CREF and / or Vanguard to open an account which will be ready to accept my fund selections after October 15 but before December 1, 2008. In that timeframe I will need to activate my web access and go to the site to select the funds I want. I understand that once accounts are opened for me at both investment companies if I do not select an investment fund, the contribution will be split between the two investment companies and will be deposited in the Target Retirement Fund (if to Vanguard) and the Life Cycle Fund (if to TIAA-CREF)..

Your signature on this form authorizes New York University to deposit the contribution to the **NYU Retirement Plan for Adjunct Faculty Members** into an account in your name at Vanguard and/or TIAA-CREF on or about December 1, 2008, as you have designated on this form. **If this form is not received in the NYU Benefits Office by September 26, 2008, the University's contribution will be deposited into an account in your name at The Vanguard Group, the default vendor, and invested in an age appropriate Target Retirement Fund.** You can then make transfers to Vanguard or TIAA-CREF after December 1, 2008
