Conditions Governing Publication of Fales Library Manuscripts:

1. All requests for use of Fales Library materials, whether in publications, motion pictures, videos, or performances will be considered on a case-by-case basis.
2. It is the responsibility of the patron to obtain any required copyright permissions from the copyright holder, which in some instances may be the Fales Library, before copies are made.
3. It is the policy of the Fales Library to assess a Use Fee for the commercial use of materials from its collections. The Fales Library reserves the right to judge whether a proposed use is commercial based on the nature of a project and its intended audience. The Fales Library also reserves the right to assess fees for the use of its material in non-commercial projects, in particular when use is deemed to be significant or extensive. Such fees are negotiated on a case-by-case basis and are intended to offset a small part of the Library's costs associated with processing, preserving, and public service of its manuscript collections.
4. Use fees cover non-exclusive, one-time use only unless otherwise indicated and are to be paid in advance. They are assessed in addition to any duplication costs.

6. The Fales Library requires that a complete copy of any Publication (in any medium) that makes use of its materials be given to the Library for its collections.
7. The Fales Library provides copies of its materials on a loan basis only. These must be returned promptly following use and are not to be further reproduced, retained indefinitely, sold, shared, or given to another person, company, or institution for any purpose, without the written permission of the Fales Library.
